CALL TO ORDER:

The Regular Business Meeting of the Pocono Mountain Regional Police Commission was held at the Pocono Mountain Regional Police Building and called to order at 7:10 p.m. by Chairman Moyer with the Pledge of Allegiance.

ROLL CALL:

EXECUTIVE SESSION

There was an Executive Session prior to the Regular Meeting on Personnel. The Executive Session started approximately 6:30 p.m. and ended approximately 7:05 p.m.

APPROVE MINUTES:

POLICE REPORT:

Total calls for the month of January were 1098 consisting of 985 Complaints and 113 Accidents. There were a total of 62 Criminal Arrests, 146 Traffic Arrests, 110 Traffic Warnings and 13 Ordinance Arrests.

Chief Wagner went over the monthly and year to date activity numbers per municipality as well as the UCR Crime Stats.

Motion:

Francis DePiano made a motion to accept the January Police Report, seconded by William Weimer.

Kurt Cummings asked how Marijuana offenses are dealt with now with some states having legalized it. Chief stated that Pennsylvania Law takes precedence, it's legality in another state is irrelevant here.

VEHICLE REPORT:

Chief Wagner reviewed the mileage and expense report for January.

Motion:

Francis DePiano made a motion to accept the January Vehicle Report, seconded by Brendon Carroll.

Kurt Cummings asked if there is an oil change plan with the new vehicles. Chief responded that it is a dealer perc that can be offered but we have found that it is less down time by having our mechanic doing the oil change and tire rotation, the vehicle is back on the road that same evening rather then sitting at a dealer.

• Preliminary 4th Quarter Budget vs Actual

Chief presented the Preliminary 4th Quarter Budget Report indicating that preliminary we came in 4.5% - 5% under budget pending any Financial Audit adjustments.

• Generator Repair

Chief reported that the generator that was installed with the building 20 years ago needs a new radiator, new battery and new water pump for the engine. Emergency Systems Service Company who services the generator

quoted \$7,249.20 to do the repairs. Discussion continued regarding the repair and the possibility of replacing the generator. More research is needed to determine which route to take. Tabled until next month.

• Well Water

Chief advised that due to having a public restroom in the lobby we are required to have our water tested monthly. The last test came back with Coliform in the water. After discussion with the plumber, the well pipe was installed at ground level, which was code at the time the building was built, but now surface water may be seeping in. With the emergency situation Chief indicated that he has authorized moving forward and will be getting quotes for the excavation and installation of a well casing extension..
